Bilal liked Hakeem's idea and asked if he could also put some money into the account where upon Hakeem agreed. On 27 Rajab, 1439 Bilal put \$3,000.00 in the savings account.

- 1. On Rajab 27, 1439 how much money is in the savings account all together?
- 2. If one year passed how much zakat would Hakeem pay if the balance remained the same and the nisaab is \$3,400.00?
- 3. If one year passed how much zakat would Hakeem pay if the balance remained the same and the nisaab is \$3,400.00?
- 4. Should Hakeem and Bilal pay separate zakat payments or a combined payment?
- 5. If Hakeem is obligated to pay zakat, what date must he pay it?

Maryam fulfills all the conditions that obligate her to pay zakat. She has 130,000.00 in the bank. How much zakat should she pay?

Abdullah fulfills all the conditions that obligate him to pay zakat. He has 35,000.00 in the bank. How much zakat should she pay?

Yusuf fulfills all the conditions that obligate him to pay zakat. He has 145,000.00 in the bank. How much zakat should she pay?

Situation #2:

On Ramadan 5, 1440 Bilal deposited \$2,050.00 in his bank account.

On Ramadan 15, 1440 he deposited \$1,350.00 in his account.

On Dhul Hijjar 4, 1440 Bilal's brother needed a loan of \$600.00. So he gave him the money as a gift and told him don't worry about paying it back.

On Dhul Hijjar 14, 1440 he received a special bonus from his job for \$3,000.00. He spent \$1,500 and put the rest in his bank account.

Questions:

- 1. Presently how much money does Bilal have in the bank?
- 2. When should he pay zakat on his money if he keeps the amount for one Islamic year?
- 3. How much zakat should Bilal pay?
- 4. How much money does Bilal's brother owe him?
- 5. Was Bilal sinful for spending his money before paying zakat on it?

Situation #3:

Maryam won \$8,000.00 after taking first place in a state wide Qur'an contest on December 5, 2014. She was rated as the best Qur'an reciter in North Carolina.

On December 19, 2014 she opened up an account at BB&T and deposited \$6,000.00. With the other \$2,000.00 she gave it to the Masjid for *sadaqah* in order to help the poor and needy.

On January 19, 2015 Maryam's brother Jihad told her that she should pay zakat on the money. She went to the Imam of the Masjid and asked about how to pay zakat.

Questions:

- 1. On what date does Maryam pay her zakat?
- 2. How much does she pay when the correct date comes?
- 3. Maryam is only 8 years old, is she obligated to pay zakat?

4. How does Maryam find the current value of gold?

Situation #4:

Umar opened up a computer repair shop downtown Raleigh. He saved enough money to buy a bigger store within 10 months. Every month he put \$2,500.00 in the bank until he had enough money to move into a bigger place. After purchasing the new store in Shawwal 1437 he had \$3,000.00 left in the bank

By Shawwal 1438 he only had \$2,500.00 in the bank.

By Shawwal 1439 he had \$3,800.00 in the bank.

By Shawwal 1440 he had \$5,000.00 in the bank.

- 1. How much money did Umar save after 9 months?
- 2. Is Umar obligated to pay zakat in Shawwal 1439?
- 3. How much zakat does Umar pay in Shawwal 1440?
